

Use of URS/SAC Certification Mark

Certification Marks Regulations and Rules

As a registered Client, Entity, or Person, you will be entitled to use the relevant certification mark. Before you use, please take the time to read the rules and regulations pertaining to the use of the certification mark stated below.

Regulations and Rules of Application



- 1. The SAC accreditation mark must be reproduced in the official colours Red (Pantone 032C) and dark grey (Pantone 432C).
- 2. The SAC mark may be uniformly enlarged or reduced but shall not be less than 15mm in height.
- 3. URS/SAC certification mark may be used on publicity and other stationery materials such as brochures, name card, letterhead paper, quotations, websites and vehicles.
- 4. The certified organization shall:
 - Conforms to the requirements of URS when making reference to its certification status in communication media such as the internet, brochures or advertising, or other documents;
 - b. Does not make or permit any misleading statement regarding its certification;
 - c. Does not use or permit the use of a certification document or any part thereof in a misleading manner;
 - d. Upon withdrawal of its certification, discontinues its use of all advertising matter that contains a reference to certification, as directed by URS;
 - e. Amends all advertising matter when the scope of certification has been reduced;
 - f. Does not allow reference to its management system certification to be used in such a way as to imply that URS certifies a product (including service) or process; (i.e not to use URS/SAC certification mark on any test items, products or literature or in a way that may be interpreted as denoting product conformity);
 - g. Does not use URS/SAC certification mark on laboratory test, calibration or inspections reports or certificates;
 - h. Does not imply that the certification applies to activities and sites that are outside the scope of certification;
 - i. Does not use its certification in such a manner that would bring URS and/or certification system into disrepute and lose public trust;
 - j. Only claim that it is certified in respect to those activities which are covered under its scope of certification.
- 5. Please note that the auditor is obliged at every visit to check the use of certification mark and should he or she note that an incorrect certification mark is being used or a proper certification mark is being used incorrectly, then a non-compliance will be raised and you will be requested to remove the certification mark from all use.
- 6. In addition, if it is determined that incorrect references to certification status or misleading use of certification document, certification mark or report has occurred, additional actions could be taken by URS including suspension, withdrawal of certification, publication of the transgression and, if necessary, legal action.
